Fall Foliage Ride ... Last in the hunter pace fundraising series

Directions: **From Route 101:** Take a right turn off the ramp for Exit 5, onto Rt.102/107. Turn right onto Rt. 27 East. Go one mile and turn left onto Ham Road. Fine Nest Farm is less than a half-mile on the right, at the top of the hill. Look for the red roof. Look for Wentworth Hunt signs for parking in the field past the house.

From Points North via Route 125: Follow Route 125 south from the Lee traffic circle toward Epping. Turn right onto Rt. 27 West. Go just less than four miles and turn right onto Ham Road. Fine Nest Farm is less than a half-mile on the right, at the top of the hill. Look for the red roof. Look for Wentworth Hunt signs for parking in the field past the house.

Times: Indicate preferred time on entry form. **Rideout is between 9:00 and 11:30am.**
Preferred times will be given to pre-registered riders.

Divisions: Hilltop and Field. Fences maximum height 3' (all gapable)

Weather: PACE WILL BE HELD RAIN OR SHINE.

Entries: Pairs or teams of three or four. ... *(No team? We'd be happy to match you up!)*

Dress: Certified helmet & hard-soled shoes with heels required. Tack must be in safe, working condition..

Awards: Six ribbons in competitive divisions (none in non-comp.) Series end awards.

Fees: Hilltop/Field Divisions \$35.00
Juniors (25 years and younger) 15.00
Non-competitive/Trail Ride 33.00
\$5 off entry fee if received by Sat. Oct 9th
